- j) Amherstburg Karate Club will be closed for two (2) weeks in December to observe the Holiday Season. Notice will be given 30 days in advance, and there will be no lessons re-scheduled in lieu of.
- k) Competent instruction for teaching lessons shall be provided by Amherstburg Karate Club throughout the term of this agreement.
- I) The Client represents that he or she is physically fit to participate in the prescribed course of instruction, and is not suffering from any medical condition, physical limitation or mental limitation that cannot be accommodated for, which may be aggravated by strenuous physical exertion. The undersigned Client hereby assumes all risk of injury that may arise from the physical exertion, as well as physical contact and interaction with others required in learning and practicing martial arts and general fitness activities.
- m) The undersigned Client herby waives any claims for loss or damage to property or personal injury or death that may occur while on the premises or participating in any activity involved with Amherstburg Karate Club, however caused, unless directly caused by the gross negligence of the persons in charge of the premises or activities at the time of such loss or injury.
